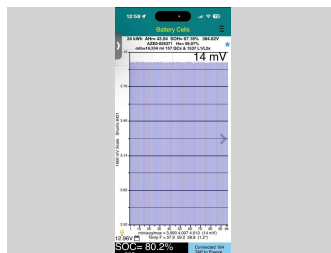

The total amount of repayments has been calculated by multiplying 156 weekly repayments (based on a 36 month term) by the weekly repayment amount of \$64.10 which equals \$9,999.44.
